Policy on English as an Additional Language (EAL)

1 Introduction

- 1.1 65% of our pupils are from minority ethnic groups and are believed to have English as an additional language. All our children are important, and this applies to all aspects of their education – their teaching and learning, their achievements, their attitudes and their well-being. We encourage all our children to aim for the highest possible standards, and we take account of each child's individual needs and experiences.
- 1.2 A number of our children have particular requirements with regard to learning and assessment, and these are linked to their progress in learning English as an additional language.
- 1.3 Children who are learning English as an additional language have linguistic skills similar to those of monolingual English-speaking children. Their ability to participate in the full curriculum may well be in advance of their current ability to communicate in English.
- 1.4 Being a speaker of more than one language is no disadvantage to educational achievement; indeed, multilingualism is associated with success. This school recognises the importance of community languages in their own right, and the ability of their speakers to acquire other languages.

2 Aims and objectives

- 2.1 It is the entitlement of all children to access certain areas of learning, and thereby to acquire the knowledge, the understanding, the skills and the attitudes that are necessary not only for their self-fulfilment, but also for their development as responsible citizens. We seek to honour this entitlement through the education that we provide at Saint Augustine Webster Catholic Voluntary Academy.
- 2.2 The aim of this policy is therefore to help to ensure that we meet all the needs of those children who are learning English as an additional language. This is in line with the requirements of the Race Relations Act 1976.

3 Teaching and learning style

- 3.1 In our academy (see also 4.4 re Foundation Stage), teachers use various methods to help children who are learning English as an additional language:
 - 3.1.1 We develop their spoken and written English by:
 - modelling and providing a language rich environment;
 - ensuring that vocabulary work covers the technical as well as the everyday meanings;
 - covering not just key words, but also metaphors and idioms;
 - explaining how spoken and written English have different usages for different purposes;
 - providing them with a range of reading materials, to exemplify the different ways in which English is used;
 - giving them appropriate opportunities for talking, and using talking to support writing;
 - encouraging them to relate one language to another;
 - 3.1.2 We ensure their access to the curriculum and to assessment by:
 - using texts and materials that suit their ages and learning stages;
 - providing support through ICT, video and audio materials, dictionaries and translators, readers and amanuenses;
 - using the home or first language where appropriate.

4 EAL and inclusion

- 4.1 At Saint Augustine Webster Catholic Voluntary Academy, we value each child as a unique individual. We will strive to meet the needs of all our children, and to ensure that we meet all statutory requirements related to inclusion. All children in our academy follow the requirements of the curriculum. Children with English as an additional language do not produce separate work. We provide learning opportunities that enable all pupils to make good progress. We strive hard to meet the needs of all pupils learning English as an additional language, and we take all reasonable steps to achieve this.
- 4.2 We do not withdraw children from lessons to receive EAL support. We have a team of Ethnic Minority Achievement staff who work in partnership with class teachers within classrooms. This involves supporting individual children or small groups of children and if required teaching the whole class, to provide a good speaking model for the children with English as an additional language.
- 4.3 In the Foundation Stage, we provide opportunities for children to develop their English, and we provide support to help them take part in all activities. We have a Polish speaking teacher and member of the EMA team working full time in the Unit. They work with children and liaise with parents.
- 4.4 The Foundation Stage helps children learning English as an additional language by:
- building on their experience of acquiring language at home and in the wider community, so that this experience supports their developing use of English;
 - providing a range of opportunities for them to engage in English speaking and listening activities, with peers and with adults;
 - providing bilingual support to extend vocabulary when possible;
 - providing opportunities for children to hear their home languages, as well as English;
 - providing a variety of writing in the children's home languages, as well as in English.

5 Assessment for learning

- 5.1 The statutory assessment arrangements allow us to make special arrangements for children who are learning English as an additional language.
- 5.2 In the mathematics tasks and tests at Key Stage 1, we are, where possible able to help children with EAL by translating English words or phrases in the assessment materials, or non-English words or phrases that the children use in their responses.
- 5.3 For the science and written mathematics test at Key Stage 2, we are, where possible able to provide verbal or written translations of words or phrases in the test papers which we think are likely to prove difficult to children for whom English is an additional language. For the mental arithmetic test at Key Stage 2, we may provide a verbal translation of the test to children who have limited English.
- 5.4 If needed, the Ethnic Minority Achievement team can help children during the Key Stage 1 and Key Stage 2 assessment periods.

6 Monitoring and review

- 6.1 This policy is monitored by the governing body, and will be reviewed in two years, or earlier if necessary.
